Fees are non-refundable from 1<sup>st</sup> May 2024. **Payment of Invoice:** Interac, Wire transfer, Cnd. cheque, **VISA**, or **MasterCard** (3% non-refundable CC Processing Fee)

**Important Information about Camp Chikopi Enrollment Terms and Conditions, 2024**

1. All fees are in Canadian Dollars.
2. A \$500 **non-refundable** deposit is required with every enrollment. The \$500 **non-refundable** deposit is applied to the invoice.
3. Invoices can be paid using Interac, Wire transfer, Canadian cheque, VISA or MasterCard. (3% Credit Card Processing Fee)
4. A VISA or MasterCard Credit Card is required to be on file with your son's enrollment.
5. Invoice is due in full by 30<sup>th</sup> April 2024. Cancellation fees: \$500 before 31<sup>st</sup> March 2024. \$1000 between 1<sup>st</sup> – 30<sup>th</sup> April 2024. No refunds after midnight EST on 30<sup>th</sup> April 2024. No credit is given for late arrivals or early departures.
6. Early Registration Discounts expire at midnight on the date shown. The **FULL** invoice must be paid by the date shown. Please do not ask for an extension, no exceptions will be made.
7. In the event of a medical withdrawal after 30<sup>th</sup> April 2024, a credit will be applied to the following summer. A letter from your son's medical Doctor must be provided.
8. In the event that a pandemic or weather-related disaster cancels or closes Camp Chikopi, or requires you to cancel your camper attending Camp Chikopi, refunds will be at the discretion of the Director and Board of Directors.
9. The cost of travel from and to Toronto is subject to change if we continue to experience high increases in fuel and bus rental costs. Custom transport/supervision fees will be charged to the camper's tuck shop account.
10. The parents/guardians listed on the enrollment form agree to pay the full invoice by the due date. Chikopi reserves the right to cancel enrollment if the invoice is not paid in full by the due date. All late payments will be charged late payment fees at the rate of 24% per annum, accruing daily.
11. Any balance owing on an account will be sent to a collection agency, late payment fees and all costs of recovery will be added to the outstanding invoice.
12. A session may be changed or extended, subject to availability and a possible service fee. A revised invoice will be issued.
13. Detailed Transport information is available in our Travel Information Form. If you are unsure about Toronto arrival or departure times, please contact the business office before you book a flight. Camp Chikopi is not responsible for any errors in booking flights.
14. Enrollment Credit – Families enrolling more than one sibling at Camp Chikopi will receive 5% Tuition discount for the second child and 10% Tuition discount for the third and following siblings.
15. Referral Credit – Families referring a **new** family who enrolls a Camper will receive a \$100 credit per Camper. Credits will be applied at the end of summer.
16. Camp Chikopi assigns campers to cabins based on their age as of 1<sup>st</sup> July 2024.
17. Camp Chikopi maintains a Code of Conduct for campers, and reserves the right to assess a Camper's behavior, to revise a Camper's stay, or to dismiss a Camper early, when it is deemed necessary and in the best interest of the camper and Camp Chikopi. No refunds shall be given in these cases. Parents agree to provide full information on their Campers behaviour and emotional issues in advance of enrollment and update the camp with any ongoing or new issues prior to arrival at Camp Chikopi. By enrolling your son and paying your deposit and invoice, you are agreeing to these terms.
18. Enrolling at Camp Chikopi grants us your permission to use photos/video of your child for Camp archival records or promotional purposes.
19. Enrolling at Camp Chikopi grants us your permission to email you Chikopi promotional information and newsletters.
20. Your signature below gives Chikopi explicit consent to collect your personal information. The data will be used for sales and marketing purposes only, it will never be given to a third party except in the case of an emergency.

I desire my child to participate in the full camp program and all activities including day trips by vehicle and or canoe, unless I advise the Camp as to any restriction in writing. In consideration of the acceptance of my child into the camp program, I authorize Camp Chikopi to secure medical treatment for my child when appropriate. If for any reason my child requires medical attention beyond that furnished by the camp, I agree to be responsible for any additional expenses incurred. I release, indemnify, covenant not to sue, and hold harmless Camp Chikopi, its owners, administrators, directors, agents, officers, volunteers, employees, other participants, sponsors, advertisers, any owners and lessors of premises on which the program takes place from all liability, any losses, claims, demands, costs, or damages that my minor child may incur as a result of his/her participation and further agree that if, despite this "Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement," I or anyone on my behalf, makes a claim against the Releases I will indemnify, save, and hold harmless each of the Releases from any litigation, expenses, attorney fees, loss, liability, damage or cost which may incur as a result of such claim. I acknowledge that the camp activities and any medical treatment will be performed in the Province of Ontario, and that the Courts of Ontario shall have exclusive jurisdiction over any claims, legal dispute or cause of action arising out of my child's stay at Camp Chikopi. I hereby agree that if I commence any legal proceedings, they will be held only in the Province of Ontario, and I hereby irrevocably submit to the exclusive jurisdiction of the Courts of Ontario. I have read, understood, sought legal advice if necessary and agree to all of the above terms and conditions of enrollment and payment of the total camp bill to be applied to the above camper's account. I understand that my signature below and payment enclosed are required to secure my son's enrollment.
